Motion to approve minutes as distributed by Bertram, second by Wilkening. Motion carried, all voting for.

#### Hardrives CUP Amendment Request -

- Kelli Neu distributed and reviewed information including staff memo, CUP amendment application and map (file CUP: JPB 2014-02:Hardrives/Vonco II)
- Questions directed to Kevin Gannon and Kelli Neu
  - Q: April 1, 2014 do you think this is realistic? A: Probably not this year, but we need to be ready just in case weather permits.
  - Q: Just for this year? A: No, from this time forward. Kelli reminded board that a CUP goes with the land and does not expire.
  - Q: What did the Planning Commission think? A: The Planning Commission is ok with Hardrives if the insurance requirements are met and they stay off of township road 137<sup>th</sup>.
  - Q: Is there a deadline for April? A: April 14<sup>th</sup> is the date we are scheduled to start.
     There will be nightwork for 10 days to start off. All for temporary asphalt, then it comes back out. If temperatures are correct, the shoulders will stay as laid there will be concrete on top. Similar to the Clearwater to St. Cloud project.
  - Q: Will the aggregate be your own or will you bring it in? A: Most will be brought in.
  - o Q: Will you be sure to follow the road restrictions? A: Yes.

#### **Angell Boundary Adjustment**

- Brian Praske addressed questions regarding this adjustment and showed upcoming plat adjustment anticipated.
- Boundary adjustment makes sense to fix this up now.
- Discussion regarding right of way plat vs. easement
- Q: is this a major change? A: not really, new description and fixing property lines.
- Sarah Angell owns it all right now so it will be cleaner to fix now rather than waiting.
- JPB Staff recommends further 'clean-up' by moving the area now shown for future plat to include the 66' right-of-way. Especially since she owns it all at this time.
- No change in lots just a dedication of the full 66' township right of way and approach permit/easement would be given to the properties.
